Editorial

The creation of the One Sustainable Health for All Foundation on September 1st, 2020, under the aegis of the Bullukian Foundation, is an initiative in response to the COVID-19 wave.

It is part of a holistic approach to health at the heart of the Sustainable Development Goals (SDGs 2030). In particular, it aims to contribute to the development of partnerships between public and private actors, with innovative, multidisciplinary and multisectoral actions integrating human, animal and environmental health issues.

The COVID-19 pandemic highlighted our human, institutional and environmental weaknesses. It showed that we are not sufficiently prepared for the emergence of infectious diseases that can only be contained through an integrated, equitable and global health approach.

Our first commitment was signed on 26 October 2020 with the World Health Summit in Berlin to launch the One Sustainable Health (OSH) Forum jointly. Thanks to the recommendations of a multidisciplinary scientific advisory board and convinced of the need to accelerate the operational implementation of the One Health approach, we were able to organize six international working groups in 2021. Their members are currently working to recommend innovative operational modalities to develop the implementation of the One Health approach. Restitution is planned at the beginning of July 2023 in Lyon within the framework of an event which will gather all the members of the OSH Forum with their partners.

In addition to the OSH Forum, the One Sustainable Health for All Foundation was able to launch an initiative for a Europe of Health in November 2021, in line with the priorities of the French Presidency of the European Union (2022). It gave rise to an event in Lyon on February 8th, 2022, during which the main recommendations made by professional organizations from European civil society (associations, foundations, universities, companies, etc.) were communicated.

We were able to convey our key messages to the mayors of major European cities gathered in Lyon on February 9th, as well as to the 27 European Union health ministers gathered in a One Health session on February 10th in Grenoble. This initiative in favour of a Europe of Health is ongoing and will be transformed in 2022 into a "One Europe for Global Health" coalition, bringing together a diversity of European civil society organizations.

We would like to thank all the experts involved in the OSH Forum and the One Europe for Global Health coalition. These first two initiatives were made possible thanks to the support of foundations such as the Bullukian Foundation, the Daniel and Nina Carasso Foundation, the Fondation de France, the Veolia Foundation, the Fondation de l'Avenir, the Edmus Foundation, the BNP Paribas Foundation and the Hippocrène Foundation.

We invite you to discover the first actions carried out by the One Sustainable Health for All Foundation and to join us to increase our capacity for action together!

1. Mission and organisation of the One Sustainable Health for All Foundation

1.1. Mission statement

The creation of the One Sustainable Health for All Foundation on 1st September 2020, under the aegis of the Bullukian Foundation, is an initiative in response to the COVID-19 wave. It is part of a **holistic approach to health at the heart of the United Nations 2030 Sustainable Development Goals (SDGs)**.

The aim of the One Sustainable Health for All Foundation is to **contribute to the development of health that should be accessible to the greatest number of people, through an approach without borders between human, animal and environmental health**. This is achieved by strengthening dialogue and international cooperation between public and private actors working in these fields. The Foundation organises and participates in events to promote sustainable health for all (webinars, conferences, etc.).

The Foundation encourages partnerships between public and private actors, with innovative, multidisciplinary and multisectoral actions integrating human, animal and environmental health issues.

In addition to the One Sustainable Health (OSH) Forum opened in April 2021, the One Sustainable Health for All Foundation was able to launch an initiative for a Europe of Health in November 2021, in line with the priorities of the French Presidency of the European Union (2022).

These two main actions allow for the **creation of exchanges between various public and private actors**, as is the case in the framework of the Strategic Partners Committee (SPC) of the OSH Forum or through the International Working Groups. Nearly fifty different organisations, associations, foundations, universities and companies are currently working together through the OSH Forum or the Coordination Committee of the One Europe for Global Health coalition.

2. Building the OSH Forum

The OSH Forum was initiated by a memorandum of understanding signed on October 26th, 2020 in Berlin between the One Sustainable Health for All Foundation and the World Health Summit (WHS), founded by Professor Detlev Ganten of the Charité – Universitätsmedizin Berlin.

Its objective is to contribute to the implementation of the One Health approach, within the framework of a collective approach allowing the creation of synergies between researchers, operators and their public and private partners.


The OSH Forum's approach is in line with the dynamics of the Treaty of Aachen (2019) between France and Germany, which stipulates that *"The two countries shall work to strengthen the process of implementing multilateral agreements in the fields of sustainable development and global health, as well as climate and environmental protection, in particular the Paris Agreement of 12 December 2015 and the 2030 Agenda for Sustainable Development of the United Nations."*

To address our health challenges, we need to consider the continuum that exists between the environment, animal health and human health (One Health concept) in a holistic approach without geographical boundaries (Global Health concept), aligned with global values that promote equal access for all (Universal Health Coverage concept).

This continuum requires a holistic, multidisciplinary and multisectoral approach to human health, aligned with our universal values in favour of equal access for all.

Everyone is invited to contribute to making global health, a public good, accessible to as many people as possible.

The Tripartite Group and UNEP endorse the definition of the "One Health" principle formulated by OHHLEP - www.who.int



2.1. Objectives and engagement

The OSH Forum aims to operationalize an integrated, equitable and comprehensive approach to health. It should facilitate collaborative work which is now essential to define the global priorities and operational actions needed to achieve sustainable health for all. This requires the involvement of all the key actors and stakeholders in our health, in an International Forum where each one can bring their expertise and allow a true cross-cutting approach without borders.

This process will lead to the recommendations of new operational actions in the field and for public policies in favour of sustainable health for all. These actions and recommendations will be closely linked to changing economic, social, energy and ecological trajectories in order to contribute to the achievement of the 2030 Agenda of the United Nations SDGs.

The OSH Forum integrates the challenge of the 2030 SDGs with the One Health approach, an integrated and unifying approach that aims to balance and sustainably optimize the health of people, animals and ecosystems. It adheres to the definition established in January 2022 by the One Health High-Level Expert Panel (OHHLEP) which emphasizes that

"The One Health approach mobilizes multiple sectors, disciplines and communities at different levels of society to work together to promote well-being and address threats to health and ecosystems, while addressing the collective need for clean water, energy and air, safe and nutritious food, taking action on climate change, and contributing to sustainable development."

The main objectives of the OSH Forum are:

- 1** To facilitate a community of international experts from diverse backgrounds, both public and private, to facilitate convergence between the various pre-existing approaches that take into account the continuum between ecosystems, animal and human health and societies as a whole.
- 2** Organize events to affirm the importance of a holistic approach to health in the implementation of the SDGs, through the development of integrated "One Health" projects.
- 3** Promote the sharing of knowledge and skills to enable the joint proposal of new operational modalities integrating the One Health concept.
- 4** Promote initiatives to translate the 2030 SDGs into practical and achievable programs, interventions and policies, with a holistic approach to health issues.
- 5** Raise awareness and facilitate the development of key training programs to support a more cross-cutting and integrated approach to One Health programs.

Engagements:

- Ensure gender balance and equitable representation of the world's major regions in its membership.
- Actively engage in measuring and controlling its carbon footprint (e.g. teleworking; online seminars and meetings; rail travel)

2.2. International Working Groups

The OSH Forum has launched 6 International Working Groups in July 2021 which aim to contribute to:


1- **Identifying operational programs and pilot actions to be developed** in the framework of a One Sustainable Health approach, based on a cross-cutting and multidisciplinary process led by a community of experts (public and private operators, researchers and "regulators" in the sense of those responsible for regulations and standards).

2- **Contributing to mitigating the existing "silos" between the different disciplines** interacting with our health issues, by organizing interdisciplinary/ multisectoral analyses and work allowing for a holistic approach to health that integrates the One Health reality with the ODD 2030 priorities.

3- **Formulating operational recommendations that will be integrated into a "One Sustainable Health Declaration"**, to be published in Spring 2023 in Lyon. This OSH Forum Declaration will provide guidelines for operational programs and public policies with strong recommendations for both public and private actors to promote sustainable health for all.

The theme of each of the 6 working groups is the result of the consultations of the OSH Forum Scientific Advisory Board, which includes some twenty international experts. Annex 4

The members of the Scientific Advisory Board agreed during the first half of 2021 to define the themes of 6 International Working Groups, trying not to reproduce a siloed approach, while outlining the priorities between groups. *More on the IWG in Annex 3*



Each Working Group includes 3 types of expertise:

- Researchers who provide knowledge;
- Operators who provide the practical implementation issues;
- Regulators who decide and administer the rules and standards.

A core group has been set up for each Working Group in the autumn of 2021 with the validation of terms of reference, a work plan including consultations and areas of analysis by field of knowledge and practical implementation.


Around their theme, the Working Groups carry out precise contextualization work. They gather scientific evidence and summarize the main challenges to the implementation of One Health actions and identify stakeholders to link with. They consider key areas throughout their work which will be reflected in the final recommendations.

The recommendations made by each Working Group should take into account the following five deliverables:

- **ADVOCACY** - Comprehensive vision and integrated approach.
- **PROJECTS & RECOMMENDATIONS OPERATIONAL** - Focus on implementation.
- **RESEARCH** - Strategic agenda for interdisciplinary research.
- **EDUCATION & COMMUNICATION** - Sharing knowledge, facilitating behaviour change and raising awareness.
- **ETHICS** - Shared values.


The **Scientific Advisory Board** remains involved throughout the Working Group development process through the 6+1 Committee. It brings together representatives from each of the 6 Working Groups with members of the Scientific Advisory Board. Its role is to regulate the priorities and ensure that the Working Groups are working in line with the defined objectives and expected results.

2.3. Organisation of the OSH Forum

The One Sustainable Health for All Foundation is leading the One Sustainable Health (OSH) Forum in partnership with the World Health Summit (WHS) in Berlin and the Geneva Health Forum (GHF).



The organisation of the OSH Forum is based on a balance between, on the one hand, the **International Working Groups (IWGs)** which bring together a wide range of experts and, on the other hand, the **Strategic Partners Committee (SPC)** which brings together a diversity of organisations. The experts involved in the IWGs are invited to share their knowledge and recommendations independently of the organisation to which they belong. The member organisations of the Strategic Partners Committee are invited to react to the relevance of the recommendations proposed by the IWG experts. In this way, the aim is to ensure that the experts' recommendations are objective (IWGs) while at the same time ensuring their operational relevance (SPC).

Between these two complementary dynamics lies the **Strategic Orientation Committee (SOC)**, whose role is to regulate priorities and ensure the proper development of the OSH Forum. It also supervises the priorities of the Steering Committee.

The **Scientific Advisory Board (SAB)** is composed of {20} recognized experts who have defined the 6 themes of the International Working Group. They ensure that the **discussions and recommendations of each Working Group are evidence-based** and that the participating experts have **no conflict of interest** when formulating ideas and positions. The Scientific Council also **facilitates the collective inter-group discussion within the "6+1" Committee** in order to deliver an overall vision, which will be translated into operational recommendations in 2023. It can validate the setting up of additional Working Groups if needed, which should be addressed by the OSH Forum.

The members of the Scientific Advisory Board participate as scientific advisors to the Working Groups. They ensure that all objectives are addressed and oversee the drafting of the good practice documents and recommendations that will constitute the One Sustainable Health Declaration in 2023.

The **Strategic Partners Committee (SPC)** comprises about 40 different organizations and its mission is to:

- Promote OSH Forum within the organization and its networks.
- Participate in the quarterly meetings of the OSH Forum SPC.
- Contribute to the strategic reflection of the OSH Forum approach.
- Facilitate the development of the OSH Forum approach.
- Disseminate and implement the OSH Forum recommendations from the international working groups.

The SPC brings together public (institutions, universities, academies, etc.) and private (NGOs, foundations, companies, etc.) organisations that wish to contribute to the development of the OSH Forum initiative, aligned with the 2030 SDGs and in favour of sustainable health for all. Each member of the SPC is involved to contribute to the development of the public benefit of the OSH Forum approach and not acting in favour of their individual interests.

3. European Health Initiative

On the occasion of the French Presidency of the European Union (FPEU) during the first half of 2022, a joint meeting of the European Ministers of Health and the European Ministers of Foreign Affairs was scheduled in Lyon on February 9th and in Grenoble on February 10th, 2022. In this context, members of the OSH Forum wished to seize this opportunity **to promote recommendations for a Europe of Health that could integrate the One Health and Global Health priorities.**

On November 25th, the One Sustainable Health for All Foundation organized a first meeting of a Steering Committee with Ole Petter OTTERSEN, Detlev GANTEN, Karin SIPIDO, Andrea WINKLER and Babette SIMON. It was proposed to invite professional organisations from European civil society to consolidate their recommendations in favour of the construction of a Europe of Health. The input of the European Health Forum Gastein, which had already published a manifesto for a Europe of Health, facilitated synergies.

The One Sustainable Health for All Foundation was able to rely on members of the OSH Forum to bring together various European organisations interested in promoting the construction of a Europe of Health.

With the support of several foundations, including the Bullukian Foundation, the Fondation de l'Avenir, the Edmus Foundation, the BNP Paribas Foundation and the Hippocrène Foundation, **an event was organized on 8th February 2022 in Lyon to promote a set of recommendations. They were communicated directly in person at a seminar of European Health Ministers in Grenoble on February 10th and the day before, on February 9th, to mayors of major European cities.**

These consolidated recommendations are the result of collective work with foundations, associations and European universities. The presentation to the European health ministers on February 10th was made during a session devoted to the One Health approach for Europe.

At the end of the event organized on February 8th to promote recommendations for the construction of a Europe of Health, most of the stakeholder organisations expressed their wish to see this initiative continue during the next presidencies of the European Union. Therefore, during the next World Health Summit in Berlin on October 16th, 2022, the One Sustainable Health for All Foundation will organize the next session with the members of the One Europe for Global Health coalition as partners, which is the continuation of the initiative organized on February 8th in Lyon.

During the Swedish presidency in the first half of 2023, a session is planned for February 9th, 2023 in Stockholm in partnership with the Karolinska Institutet, whose president, Ole Petter OTTERSEN, is the main driver of this coalition for a Europe of Health, along with Professor Detlev GANTEN.

This initiative in favour of a Europe of Health fits well with the mission of the One Sustainable Health for All Foundation, which aims to strengthen the synergies between public and private actors in favour of sustainable health for all. Health is not yet a shared competence in Europe and the COVID-19 pandemic has shown the interest of having a strong and organized Europe to face its health challenges together.

6 . Perspectives 2022

The two main activities of the One Sustainable Health for All Foundation continue in 2022 with the following perspectives:

OSH Forum



The challenge for the OSH Forum in 2022 is the development of the 6 International Working Groups as well as the development of the Strategic Partners Committee, which allows to welcome a great diversity of complementary international organizations.

Each of the 6 International Working Groups (IWGs) will be enriched with new competencies to reach an average of 20 to 25 experts per group, with the maintenance of a core group of 5 to 7 active experts around the two to three co-chairs. The terms of reference for each of the IWGs having been validated, a 2022 action plan for each of the 6 IWGs will be circulated. It is also planned to recruit an assistant for the general organization of the 6 IWGs and a post-doc for each of them in order to be able to deepen the "research-action" aspects for each of the 6 IWG themes.

In order to have the necessary means to carry out the development of the 6 IWGs, a new phase of partnerships with European foundations, in addition to the first French foundations involved, will be launched during the second half of 2022. The confirmed interest of the Health Department of the French Development Agency (AFD) will certainly give the OSH Forum new capacities for international actions. This should enable us to support the development of the OSH Forum, which requires additional resources due to its expansion.

During the year 2022, the OSH Forum team will participate in a number of events in France and internationally to raise awareness of its actions. It also plans to organize an OSH Forum session on May 4th during the Geneva Health Forum and on October 16th at the French Embassy in Berlin, during the World Health Summit (WHS).

"One Europe for Global Health" initiative



At the end of the event organized on February 8th in Lyon to promote recommendations for the construction of a Europe of Health, most of the stakeholder organizations expressed their wish to see this initiative continue during the next EU presidencies.

It was decided to transform the February 8th initiative in Lyon into a “One Europe for Global Health” coalition. This action fits well with the mission of the One Sustainable Health for All Foundation, which aims to promote synergies between public and private actors in favour of sustainable health for all. Health is not yet a shared competence in Europe and the Covid-19 pandemic has shown the interest of having a strong and organized Europe to face its health challenges together. Several events have addressed the issue of European health at the EUFP, and an EESC report on the subject was adopted in plenary on April 12th. There is a real interest in developing a One Europe for Global Health coalition with all the various European professional organizations concerned. This will speed up the construction of a Europe of Health, which can only be achieved in practice with the involvement of civil society, in the context of the development of health democracy.

During the World Health Summit (WHS) in Berlin in mid-October, the Foundation will host two sessions organized by the "One Europe for Global Health" coalition in conjunction with Czech organisations, whose country holds the EU presidency during the second half of 2022. Then, during the Swedish presidency in the first half of 2023, a session will be organised in Stockholm on 9th February in partnership with the Karolinska Institutet.

IWG 1 – MITIGATING THE IMPACT OF ENVIRONMENTAL POLLUTION, CLIMATE CHANGE AND PRESSURE ON BIODIVERSITY TO PROMOTE BETTER HEALTH OUTCOMES

Pollution harms citizens and ecosystems. Its most harmful health impacts are typically born by vulnerable citizens, notably children, people with pre-existing health conditions, the elderly, and people living in socio-economic deprivation. To secure clean air, water, and soil, healthy ecosystems, and a healthy living environment, territories need to better prevent, remedy, monitor and report on pollution, mainstream the zero pollution ambition into all its policy developments and further decouple economic growth from the increase of pollution as well as strengthen the inter-linkages between environmental protection, sustainable development and people's well-being, in line with United Nations driven efforts.

IWG 1 focuses on “Mitigating the impact of environmental pollution, climate change & pressure on biodiversity to promote better health outcomes.” It seeks a healthy shared environment considered a public common good; a benefit shared among all living beings on the planet, humans, wildlife, domesticated animals, and plants. IWG 1 tackles the pollution of air, water, and soil which are key drivers of biodiversity loss, through integrating and reinforcing existing solutions and identifying new solutions for environmental health components across countries, disciplines and contexts.

Throughout its mission, IWG 1 will implement the DPSIR framework. According to the DPSIR framework, there is a chain of causal links starting with ‘driving forces’ (economic sectors, human anthropic activities) through ‘pressures’ (emissions, waste) to ‘states’ (physical, chemical and biological) and ‘impacts’ on ecosystems, human health and functions, eventually leading to political ‘responses’ (prioritization, target setting, indicators)

IWG 2 – TOWARDS SUSTAINABLE FOOD SYSTEMS FOR IMPROVED NUTRITION AND HEALTH

Exacerbated by droughts, wars, and environmental problems, food Supply around the world is witnessing acute shortages which are affecting the lives of millions of people globally. There is an urgent need to meet food and nutrition needs at all stages of the lifecycle without compromising the ability of food systems to meet the needs of future generations. The intervention required must ensure public health is prioritized across the entirety of food systems – production, processing, packaging, distribution, marketing, consumption and disposal – and promotes equitable physical, economic and social access to diets that are health-promoting and support a diversity of cultures, socio-demographics, and lifestyles.

Working Group 2 (WG2) focuses on the related perspectives “Towards Sustainable Food Systems for Improved Nutrition and Health.” This working group addresses its objectives through a lens of achieving sustainable food systems that support better nutrition and health outcomes. The main objective of IWG 2 is to support sustainable (environmentally, economically, socially) food systems that produce adequate, diverse, healthy, safe and affordable diets for improved/optimal nutrition and health outcomes, with prioritization for the most marginalized and disadvantaged populations. The WG has identified four categories of challenges that will be addressed during its course of action.

1. Current practices in place, synergies and tradeoffs, and challenges raised by the COVID-19 Pandemic.
2. Lack of governance instruments and lack of capacity to implement a one health perspective within food systems transformation initiatives.
3. Needs to be addressed in response to food systems perspectives in different settings associated with production, mitigating against the misuse of fertilizers, chemicals and antimicrobials, as well as handling food from a food safety perspective.
4. Emerging issues in the global south as we transition to a monoculture, deforestation, and misuse of chemicals.

IWG 3 – HOW MUST HUMAN INTERACTION / RELATIONSHIP WITH NATURE TRANSFORM TO ACHIEVE ONE SUSTAINABLE HEALTH?

IWG 3 reflects on the current and future modalities of the relationship between humans and the rest of the living world in differentiated living environments, through an intersectoral approach highlighting the continuity of spaces, including territories: "South" and "North". IWG 3's approach, which is based primarily on anthropological experiences, makes it possible to overcome the usual separations in terms of risk management and governance between the North and the South. IWG 3 targets chemical risks and infectious diseases in the context of agriculture and domestication. This group proposes to take a step aside by putting populations and the relationships they have with the rest of the living world as being at the heart of sustainable health for all. To respond to the challenge of formulating operational recommendations within the framework of the OSH Forum, the two following questions will be investigated:

1. What role(s) can populations have in health and environment policies? What appropriations by citizens of health-environment issues?
2. How to build and account for knowledge and local knowledge about populations (useful for public policies) outside of 'ordinary culturalist reasoning'?

The physical areas of IWG 3's focus include Urban and land management, Land uses, farming and breeding, Coastal and oceanic areas (including fisheries), and Forests. Specific interactions between different biomes and human practices will also be targeted in the work of IWG 3.

IWG 4 – EQUITABLE ACCESS TO QUALITY HEALTH-RELATED SERVICES

In many parts of the world, there are population groups who systematically experience lower access to health services, lower health status, limited well-being outcomes and higher exposure to risks and stressors. Given the diverse characteristics and needs of different groups, health equity cannot be achieved through a one-solution-fits-all strategy.

The overall goal and purpose of IWG 4 is to contribute to achieving Health equity, and more specifically Equitable access to optimal quality health-related services, as an integral part of the One Sustainable Health agenda. IWG 4 aims to empower health-related services as effective and efficient services according to the latest scientific evidence and clinical guidelines and standards. Accounting for local culture, respecting different illness narratives, addressing the variety of coping strategies, and including healing practices are necessary steps to meet the population's needs and to satisfy providers.

IWG 5 – GLOBAL LEVERS OF CHANGE TO FOSTER ONE SUSTAINABLE HEALTH

The aim of IWG 5 is identifying and reinforcing “Global levers of change to foster One Sustainable Health”. Social, economic, environmental, agricultural, political, academic, technological, and commercial sectors are closely and dynamically connected to health, underlining the need to integrate the One Health approach across all sectors and policies. Nevertheless, governance mechanisms and institutions at the international level tend to remain squarely focused on specific sectors or topics which creates fragmentation and siloes and prevents the implementation of a correct interdisciplinary/transdisciplinary One Health approach. To ensure the sustainability of implemented actions and interventions, a holistic and coordinated approach must be adopted which involves the cooperation of interdependent sectors including research, corporations, governmental and non-governmental organizations, media, and regulatory bodies. The IWG will contribute to immediate and long-term strategic action. The IWG will map the current governance ecosystem for One health, summarize the main challenges to operationalizing the One Sustainable Health approach, propose recommendations to evolve the global ecosystem and identify stakeholders that should be engaged to address the challenges.

By doing so, IWG 5 will contribute to the realization of a common vision where the world supports sustainable health through equitable, respectful and innovative One health governance and finance by building bridges across sectors and disciplines with a prioritization for building capacity for the most marginalized and disadvantaged populations. It will identify opportunities to effect sustainable, improved change through the understanding of how the current governance mechanisms in global health, environmental and animal health, but also other sectors known to impact health (agriculture and food systems, transports, etc.) are creating opportunities for One Health and/or impeding joint work. It will also map stakeholders who focus on building capacity of the next generation of educators, policymakers, and development practitioners so that they can lead in international health management in a bid to support capacity building and communication.

IWG 6 – DEVELOPING ONE SUSTAINABLE HEALTH PRACTICES AND RESILIENCE WITHIN LOCAL COMMUNITIES

The purpose of IWG 6 is to foster the local communities through their engagement in a transformational change to improve their health and that of their environment, including that of their animals and prospects for an improved future. This is done by empowering communities, considering the cultural sensitivities and specificities across contexts, including gender, education, and access to information.

IWG 6 proposes a progressive pathway approach to developing these practices and resilience within local communities. The progressive pathway concept is a step-by-step scheme whereby small but significant modifications or inputs are instituted by all participants (stakeholders) to improve human, animal, environmental, and community health. Key to the approach is that the local community would need to develop its vision of where it wants to be by a given period of time (e.g., 5, 10, or 15 years) and identify the changes and inputs that would need to be put in place to arrive at the desired outcome. Furthermore, the metrics to show progress and identify gaps and obstacles can be equally incorporated. Recognizing the importance of a community's resilience to known or unknown threats to health, the advent of a progressive pathway scheme developed through a participatory process with local stakeholders would ensure healthy ownership.

The WG's deliverables will include concrete recommendations for practices that promote and improve the resilience of local communities.


